Alison:

Zone 4 timing equipment:

- Zone 4 has moved to a rental system, rather than purchasing the chips. Rentals can be made annually or semi-annually.
- Alison reached out the Caledonia Nordic and PG Road Runners to see if they would like to split the cost.
- Caledonia Nordic club received a quote from Zone 4: \$2,300 for 100 chips, plus the cost of shipping to return the old chips. The cost split between the clubs would be \$812.

Latest developments regarding the proposed lower parking lot:

- City PG Recent response from Dave Bradshaw:
 - Dave declined the proposal as this will not reduce the traffic on Pidherny Road.
 - Concerns around garbage collection at the new proposed parking lot.
 - Would need to expand the RSTBC site. This would require purchasing private land to access.
 - Need to have a beginner trail to access the proposed parking lot.
 - Next step is a presentation at City Council meeting.

RSTBC - Section 57 application & additional commitments from the PGCC

- Application for proposed parking lot.
- RSTBC is looking for a couple commitments from PGCC: vandalism monitoring at parking lot, and garbage pick up. This is so it doesn't fall on RSTBC.

Fire Fuel Mitigation at Pidherny

- Happening this year.
